EXECUTIVE ORDER NO. 08 Series of 2023

AN EXECUTIVE ORDER ESTABLISHING THE CAGAYAN PROVINCIAL STATISTICS CENTER UNDER THE PROVINCIAL PLANNING AND DEVELOPMENT OFFICE

WHEREAS, Republic Act No. 10625, otherwise known as the "Philippine Statistical Act of 2013" provides for the decentralization of Philippine Statistical System (PSS) and support the establishment of statistical infrastructures necessary to service the statistical needs of local development planning;

WHEREAS, the said law also mandates the Philippine Statistical Authority (PSA) to prescribe appropriate frameworks and mechanisms for the improvement of statistical coordination at the regional and local government unit (LGU) levels;

WHEREAS, the Provincial Government of Cagayan (PGC) through Executive Order No. 7, "Reconstitution of the Cagayan Provincial Statistics Committee (CPSC)," provides that CPSC shall institute measures to strengthen the statistical capacity of the provincial statistical system including institutions and personnel thereof;

WHEREAS, the Provincial Government of Cagayan (PGC) recognizes the need to enhance coordination and importance of Provincial Statistical System, to address the statistical requirements of development planning and other governance concerns and supports and complements the PSA and CPSC in the establishment of statistical infrastructures necessary to service the statistical needs of local development planning;

NOW THEREFORE, I. MANUEL N. MAMBA, Governor of the Province of Cagayan, by virtue of the powers vested in me by existing laws, do hereby order:

Section 1. Establishment of the Provincial Statistics Center under the Provincial Planning and Development Office. The Provincial Statistics Center is hereby established under the Provincial Planning and Development Office;

Section 2. Data Repository. The Cagayan Provincial Statistics Center will act as the data repository for all collected statistical reports from all CPSC member agencies in order to strategically develop and offer relevant and reliable data. It will be a portal in which the public may access all the data necessary for their needs;

Section 3. Physical Facilities. An area in the Provincial Planning and Development Office located at the Provincial Capitol Compound will serve as the one-stop shop of statistical information and central administration office that will cater to all the policy makers, investors, planners, researchers, professionals and students;

Section 4. Management and Operation of the Provincial Statistics Center. The Provincial Statistics Center will be managed and operated by the Provincial Planning and Development Office;

Section 5. Data Providers. The member agencies of the Cagayan Provincial Statistics Committee shall provide for the necessary data annually, or whenever available, submit to the PSC Secretariat;

Section 6. PSC Secretariat. The PSC Secretariat shall receive/collect, evaluate/validate and approve the uploading of submitted data;

Section 7. Repealing Clause. All issuances inconsistent with the provisions of this Order are hereby repealed or modified accordingly.


Section 8. Separability Clause. If, for any reason, any part or provision of this Order is declared invalid or unconstitutional, any part or provision not affected thereby shall remain in full force and effect.

Section 9. Effectivity. This Executive Order shall take effect immediately.

CAGAYAN PROVINCIAL STATISTICS COMMITTEE RESOLUTION NO. 01 SERIES OF 2023

REQUESTING THE HONORABLE GOVERNOR MANUEL MAMBA
TO ISSUE AN EXECUTIVE ORDER FOR THE CREATION AND ESTABLISHMENT OF
THE CAGAYAN PROVINCIAL STATISTICS CENTER UNDER THE PROVINCIAL
PLANNING AND DEVELOPMENT OFFICE AS A PROJECT OF THE CAGAYAN
PROVINCIAL STATISTICS COMMITTEE

WHEREAS, Section 6.c of Republic Act (R.A.) No. 10625, or the Philippine Statistical Act of 2013, mandates the Philippine Statistics Authority (PSA) to collect, compile, analyze, abstract and publish statistical information relating to the country's economic, social, demographic, political affairs and general activities and condition of the people;

WHEREAS, one of the objectives of the said law is to support decentralization through the establishment of statistical infrastructures necessary to service the statistical needs of local development planning;

WHEREAS, the demand for data to support development planning, implementation and monitoring of programs and projects at the local level has increased in view of the devolution and decentralization thrust of the government;

WHEREAS, Section 4 of the Provincial Government of Cagayan (PGC) Executive Order No. 7, "Reconstitution of the Cagayan Provincial Statistics Committee (CPSC)," provides that CPSC shall institute measures to strengthen the statistical capacity of the provincial statistical system including institutions and personnel thereof;

WHEREAS, in view of the foregoing, the CPSC through the assistance of the PGC shall create and establish the Cagayan Provincial Statistics Center, through a website and with physical address located at the Provincial Planning and Development Office (PPDO), PGC Capitol Complex, Tuguegarao City, Cagayan;


WHEREAS, to strategically develop and provide relevant and reliable statistics, the Cagayan Provincial Statistics Center will serve as the data bank of all collected statistical reports from all CPSC member agencies;

WHEREAS, the submission of various statistical information of the above-mentioned institutions is deemed vital in the formulation of effective policies and development of strategic plans for equitable progress and improved quality of life for Cagayanos;


WHEREAS, the information that will be gathered and compiled at the Cagayan Provincial Statistics Center shall be open and may be used by a wide range of data users such as government agencies, non-government organizations, business firms, entrepreneurs, students, international institutions, and the general public;

NOW, THEREFORE, in view of the foregoing premises, BE IT RESOLVED AS IT HEREBY RESOLVED to respectfully request the Honorable Governor Manuel Mamba to issue an Executive Order to create and establish the Cagayan Provincial Statistics Center to be based at the PPDO, PGC Capitol Complex, Tuguegarao City, Cagayan.

RESOLVED FURTHER, that the data provider representative shall annually, or whenever available, submit necessary data to the CPSC Secretariat for review and validation. Any irregularities observed in the submitted data shall be addressed by the data provider representative.
